

Cut and Cap Guidelines

Little Egg Harbor Municipal
Utilities Authority

EFFECTIVE AUGUST 12, 2014

A Licensed Plumber or Approved Contractor * is Required to Perform ALL Cut and Caps.

*** Contractor must be pre-approved by the Authority and hold a NJ DPMC27 Certification and Classifications C056 and C058, as per resolution 2014-56.**

An Inspection/Re-inspection Fee of \$50.00 is payable at the time of application. Please do not miss a scheduled appointment. **A 24 hour notice is required for ALL cancellations to avoid an additional fee.**

The Owner/Plumber or Approved Contractor must fill out the water and sewer disconnect information form.

The Authority requires a three business day notice (Monday – Friday) for a cut and cap inspection.

Water and sewer services that are cut and capped shall be done in the right-of-way, regardless of where the existing clean out or curb stop is located.

If the existing curb stop is not in the right-of-way you must inform the Authority at the time of scheduling the inspection so the Authority personnel can install a new curb stop, box and rod. The Licensed Plumber must have the water line exposed approximately 5' from edge of pavement in the right-of-way.

When the services are cut and capped, the inspection will be performed at that time.

Both water and sewer services shall be staked with a wood or metal post. These posts shall remain in place and maintained by the Owner until new connections are completed. If the stake cannot be found when the house is ready to connect, the Owner will be responsible to locate the services.

The existing water meter and transmitter are to be held by the Owner. If lost or broken, the Owner will be responsible for a replacement cost of \$150.00 for the meter and \$150.00 for the transmitter.

The Authority will contact the Owner/Plumber or Approved Contractor when the letter of disconnect is ready to be picked up.

Upon re-connection please refer to the Authority's Rules and Regulations.
