WHEREAS, the subordinate bonds to be issued pursuant to Resolution 2019-9 and Resolution 2020-16 are expected to be issued to the New Jersey Infrastructure Bank (f/k/a the New Jersey Environmental Infrastructure Trust) (the "I-Bank") and the State acting by and through the New Jersey Department of Environmental Protection all pursuant to the New Jersey Water Bank Financing Program (the "Program"); and

WHEREAS, the Authority Subordinate Bonds (as such term is defined in both Resolution 2019-9 and Resolution 2020-16) are to be issued as subordinate bonds payable from amounts which may be withdrawn from the General Fund created and established by the resolution of the Authority adopted on June 17, 1977, entitled: "Resolution Authorizing the Issuance of Revenue Bonds of The Little Egg Harbor Municipal Utilities Authority", as amended and supplemented (the "General Bond Resolution"); and

WHEREAS, bond counsel to the Authority has now advised the Authority that the financial addendum forms required by the I-Bank in connection with the Program require, among other things, that the Authority represent that subordinate bonds contain the same rate covenant as the Authority's senior lien bonds; and

WHEREAS, Section 611 of the General Bond Resolution provides that the Authority shall charge and collect Service Charges (as defined in the General Bond Resolution) as may be necessary in order that Revenues (as defined in the General Bond Resolution) collected (including moneys available to and deposited by the Authority in the Revenue Fund created by the General Bond Resolution) will be at least sufficient (a) to pay all Operating Expenses (as defined in the General Bond Resolution) and keep the Authority's system in good repair, working order and condition, (b) to provide a sum equal to 110% of the Debt Service for such Fiscal Year (as those terms are defined in the General Bond Resolution), (c) to maintain in the Bond Reserve Fund an amount equal to the Bond Reserve Requirement (as those terms are defined in the General Bond Resolution), (d) to maintain in the Renewal and Replacement Fund an amount equal to the System Reserve Requirement (as those terms are defined in the General Bond Resolution), and (e) to provide for any deficits of the Authority resulting from failure to receive any Service Charges or Annual Charges (as defined in the General Bond Resolution); and

WHEREAS, the Authority desires to approve the forms of amended and restated subordinate bond resolutions including the amendments to Section 18.

- (c) Section 18 of Resolution 2020-16 is hereby amended and restated to read as follows:
 - Section 18. Covenant to Pay Authority Subordinate Bonds; Rate Covenant in General Bond Resolution to Apply to Authority Subordinate Bonds. The Authority hereby particularly covenants and agrees with the holders of the Authority Subordinate Bonds and makes provisions which shall be a part of its contract with such holders, that the Authority will pay or cause to be paid the principal of every Authority Subordinate Bond and the interest thereon at the date and place and in the manner mentioned in such Authority Subordinate Bond according to the true intent and meaning thereof and will carry out and perform all of the acts and things required of it by the terms of this resolution. Section 611 of the General Bond Resolution is hereby incorporated herein by this reference thereto; provided that for purposes of Section 611(b) of the General Bond Resolution the Authority shall also provide for an additional sum equal to one hundred ten per centum (110%) of the debt service on the Authority Subordinate Bonds for such fiscal year.
- Section 2. Approval of Amended and Restated Mathistown Road Water Treatment Plant Subordinate Bond Resolution. The composite Amended and Restated Mathistown Road Water Treatment Plant Subordinate Bond Resolution attached hereto as Exhibit A, reflecting Resolution 2019-9 as amended by the amendment thereto approved in Section 1(b) of this resolution, is hereby adopted and approved.
- Section 3. Approval of Amended and Restated Mystic Island Sewer and Water Main Project Subordinate Bond Resolution. The composite Amended and Restated Mystic Island Sewer and Water Main Project Subordinate Bond Resolution attached hereto as Exhibit B, reflecting Resolution 2020-16 as amended by the amendment thereto approved in Section 1(c) of this resolution, is hereby adopted and approved.
- Section 4. Filing of Resolution. The Executive Director or the Secretary is hereby authorized and directed to cause copies of this resolution to be filed for public inspection in the following places: in the office of the Township Clerk of the Township of Little Egg Harbor, in the County of Ocean, New Jersey, at the Municipal Building in said Township, and in the office of the Authority at 823 Radio Road, in said Township.
- Section 5. <u>Publication of Notice</u>. The Executive Director or the Secretary is hereby authorized and directed to cause to be published, after completion of filing of copies of this resolution as directed in the preceding Section, in the "Atlantic City Press" and the "Asbury Park Press", legally qualified public newspapers circulating in the district of the Authority, a notice in substantially the form attached as Exhibit C hereto and by this reference incorporated as if set forth in full herein.

Section 6. Capitalized Terms. All capitalized words and terms used but not defined in this resolution shall have the meanings ascribed to such words and terms, respectively, in the preambles to this resolution.

WHEREAS, from time to time, the use of water in volume on a temporary basis becomes necessary or desirable for other than emergency purposes; and

WHEREAS, the Authority has determined upon the advice and recommendation of the Executive Director and Superintendent that water may be provided and measured by meter only through fire hydrants approved and directed by the Superintendent, located throughout the system; and

WHEREAS, the Authority is willing to make this source available provided the Executive Director and Superintendent are satisfied in every instance that such use does not impair or reduce the effectiveness in providing water for emergency purposes to control fire;

- 3. The charge for water so used shall be at the rate per thousand gallons fixed from time to time by the Authority. The rate is equal to the excess water charge in effect per 1,000 gallons rounded to the nearest 1,000 gallons.
- 4. The consumer shall submit, in writing, an estimate of the quantity of water to be used and shall pay the Authority, in advance, a sum equal to the anticipated usage charges. The meter shall be read at the end of each day and additional deposits may be required as directed by the Authority based on the calculated usage. It is particularly important that the estimate of the proposed water usage is accurate as the Authority has no mechanism to provide a refund of overpayment. Upon conclusion of the service and disconnection, the meter must be returned immediately in an undamaged condition. If the meter is not returned a fee of up to \$4,000 will be assessed to the consumer. If the meter is damaged, the costs to repair the meter will be performed and assessed to the consumer.

- 5. The use of these facilities is provided as an accommodation for extraordinary and unusual events and not as a regular service or where other sources of water are available.
- 6. The Authority assumes no responsibility in providing this service and the consumer by acceptance thereof by signing a copy of this resolution acknowledging its terms and conditions, waives all claims for loss or damage arising therefrom.
