C. Water:

We have the following comments:

- 1. The project is located in an active water service area. Connection of this project to the Authority's water system shall be required.
- 2. All work is to be constructed in accordance with the Authority's Rules and Regulations.
- 3. The proposed water improvements within the public right-of-way shall be owned, maintained, and operated by the Authority. A curb stop shall be installed on the proposed water service immediately within the public right-of-way and shall serve as the Authority's demarcation point.
- 4. The following is a list of items that shall be revised when resubmitting for Tentative Approval:
 - a. In accordance with N.J.A.C 7:10-11.10, NJDEP Bureau of Water System Engineering approval shall not be required for this project.
